Spaces (10x10 area) are available underneath one large tent for \$ 450. The Fair Association Chairman will determine the pricing for food vendor rental space on an individual basis. All food vendors must be pre-approved by the Mason Dixon Fair Association before the rental application will be finalized. Adjustments will be made if a larger area is required. If your Business would like to rent a space for an exhibit or advertisement, please read the enclosed provisions, complete and return the rental application by June 15, 2009. Please enclose a check or money order (no cash) made payable to: Mason Dixon Fair Association. No refund of space rental will be made after June 1, 2009.

***Provisions for renting spaces:***

1. No refunds after June 1, 2009.
2. Fees are to be paid in full by June 15, 2009. **(NO CASH)**
3. Rental application must be filled out and signed.
4. Exhibitors must supply their own lighting fixtures if needed.
5. Any music/video presentation must keep volume levels down to prevent any disturbance to others.
6. Alcoholic beverages or controlled substance prohibited on the grounds.
7. The Mason Dixon Fair Association retains all rights to restrict or reject any display.
8. Any problems or questions will be subject to the authority of Doug Farrington.
9. Mason Dixon Fair Association is not responsible for any lost, broken, stolen or damage to displays or merchandise.
10. Not responsible for any electrical power outages.
11. Exhibitors must be open 5 p.m. till 11:00 p.m. Monday - Thursday, 5 p.m. till 12:00 Midnight - Friday and 9:00 a.m. till 12:00 Midnight Saturday.
12. Food Vendors must have Pennsylvania Health certification.
13. All food and special vendors must have \$1,000,000 insurance coverage naming the Mason Dixon Fair Association and the Delta Cardiff Fire Company as additional insured. This certificate must be included with the application on or before June 15, 2008 or the application will be denied.
14. Food vendors may not sell sodas.
15. All vehicles must be removed from fair midway by starting time and parked in designated areas.
16. **All Vendors or Exhibitors MUST be set up by noon on Monday July 6, 2009. Set up time is Sunday 9 am to Monday 12 noon.**
17. All tent rentals should go through Chesapeake Rental-All (410-272-1741)
18. All food vendors are required to have a fire extinguisher on site.
19. Keep area around your booth or concession clean.
20. No real or toy guns, knives, fireworks, to be sold.
21. No dogs or other pets on the grounds, except service animals

**Traveling from Maryland.**

From Bel Air take Route 1 North turn left onto Route 543 North. Right onto 165 North. Approximately 3 miles on left at Maryland/Pennsylvania line. Drive time 15 minutes.  
From Churchville take Route 22 to Route 136 North and right onto 165 north.

**Traveling from Pennsylvania.**

From York take Route 74 South. Drive time 30 minutes. Alternate Route from York I 83 South to exit 1, Route 851 south, and right onto route 74. Drive time 30 minutes. This event is located behind the M&T Bank on Route 74 at MD/PA line.
