**General Rules:**

1. All animals for exhibit must be entered at the Fairgrounds from 4:00pm to 8:00pm on Sunday, July 8. Vet check-in is Monday 12:00pm to 4:00pm.
2. 4-H and Vocational Swine Show will be held Tuesday at 7:00pm.
3. Swine will be released on Wednesday at 10:00pm.
4. No more than three pigs per exhibitor will be accepted.
5. No more than one pair class and one pen class per exhibitor will be accepted.
6. All swine will be weighed on the same set of scales as announced.

All exhibitors are:

- subject to the General Rules and Regulations
- expected to adhere to the Code of Show Ring Ethics and Guidelines for the Care of Animals
- required to comply with the General Livestock Health Requirements
