Health Rules:

General Rules:

1. All market sheep for exhibit must be entered at the Fairgrounds from 12:00pm to 4:00pm Sunday, July 9, 2017.
2. 4-H and Vocational Market Lamb Show will be held on Monday at 6:00pm.
3. Market sheep will be released on Tuesday at 10:00pm.
4. All market lambs will be weighed in on the same set of scales on Sunday upon arrival. Exhibitor must be present at weigh-in.
5. All lambs for the Pair of Lambs class must be in the same weight class.
6. All Market Lambs must be slick shorn from the knee and hock up at the time of weighing. Lambs with excessive wool will not be weighed until shorn to meet the satisfaction of the Superintendent.

All exhibitors are:

- subject to the General Rules and Regulations
- expected to adhere to the Code of Show Ring Ethics and Guidelines for the Care of Animals
- required to comply with the General Livestock Health Requirements
