Vendor Rental Provisions

1. No refunds after July 1, 2020. Fees are to be paid in full by June 29, 2020.
3. Rental application must be filled out and signed
4. Exhibitors must supply their own lighting fixtures if needed
5. Any music/video presentation must keep volume levels down to prevent any disturbance to others
6. Alcoholic beverages or controlled substance prohibited on the grounds
7. The Mason Dixon Fair Association retains all rights to restrict or reject any display
8. Any problems or questions will be subject to the authority of the Mason Dixon Fair Association
9. Mason Dixon Fair Association is not responsible for any lost, broken, stolen or damage to displays or merchandise
10. Not responsible for any electrical power outages
11. Exhibitors must be open Monday – Thursday 5 pm – 10 pm, Friday 5 pm – 12 am (midnight) and Saturday 2 pm – 11 pm unless otherwise agreed to by Mason Dixon Fair Association
12. Food Vendors must have a Pennsylvania Health Certification
13. All food and special vendors must have \$1,000,000.00 insurance coverage naming the Mason Dixon Fair Association and the Delta Cardiff Volunteer Fire Company as additional insured. This certificate must be included with the application on or before June 29, 2020 or the application will be denied
14. Food vendors **MAY NOT** sell beverages (soda, water, etc) unless pre authorized
15. All vehicles must be removed from the fair midway by starting time and parked in designated areas
16. **All Vendors or Exhibitors MUST be set up by noon on Monday July 6, 2020. Set up time is Sunday 9 am – 6 pm** unless otherwise agreed to by Mason Dixon Fair Association
17. All tent rentals go through Chesapeake Rent-All
18. All food vendors are required to have a fire extinguisher on site
19. Keep area around your booth or concession clean
20. No real or toy guns, knives, lasers or fireworks are to be sold as well as no merchandise containing the Rebel Flag
21. No dogs or other pets on the grounds, except service animals
22. Food vendors from previous years have to June 1, 2020 to reserve their spot
23. Food vendors must have their menu approved by the Mason Dixon Fair Association
24. Two (2) week long Vendor Passes will be provided. Additional passes can be purchased through the fair office.

Anyone who does not follow these rules will be asked to leave the grounds and NO refund will be given

Getting to the Fair Grounds

Traveling from Maryland

From Bel Air take Route 1 North, Left on Route 543 North, Right onto Route 165 North. Fair Grounds are located approximately 3 miles on left at the Maryland/Pennsylvania Line. Drive time from Bel Air is approximately 15 minutes.

From Churchville take Route 22 to Route 136 North, Right onto 165 North.

Traveling from Pennsylvania

From York take Rout 74 South. Drive time is approximately 30 minutes.

Alternate Route from York - I-83 South to Exit 1, Route 851 South, Right onto Route 74. Drive time is approximately 30 minutes.

The Fair Grounds are located behind the M&T Bank on Route 74 at the MD/PA Line.
